


Goals: Reduce hotel operating costs

Areas of demand:



Electricity - lighting and power for public areas, bedrooms and hotel facilities



for swimming pools, leisure facilities and space heating



Air conditioning systems - used to keep rooms and whole complex cool

Challenges

- → Constant energy usage due to the range of facilities offered and the 24 hour nature of the portfolio
- → Need for installed equipment to be quiet in operation to avoid disturbing guests
- → Integration with the wide range of electrical and heating systems found across the hotel portfolio

The savings are being delivered by combined heat and power system (CHP) installations at every site – which have been provided on the basis that the equipment is owned, operated and maintained by EuroSite Power – thus resulting in zero capital and resource expenditure for The Ability Group. Furthermore, two of The Ability Group's sites had pre-existing, CHP systems; EuroSite Power purchased the old systems from the client, recommissioned the units and assumed all of the risk, therefore enhancing the overall potential savings.
